

Husson Stock Index
Week Ended March 5, 2021

For the week ending March 5, 2021, the Husson Stock Index (HSI) finished the week at 210.56, up 0.67% from last week's close of 209.16. In comparison to the HSI, the S&P 500 finished the week at 3,841.94, up 0.81% from last week's close of 3,811.15. Comparing the HSI and S&P year-to-date, the HSI has increased 2.18% and the S&P has increased 2.29%.

Summary

The stock with the largest percentage change for the week was Covetrus, Inc. (CVET: NASDAQ), which decreased 15.74% or \$5.85. Simply Wall Street rates the company as undervalued, but notes that revenue growth is expected to be lower than the U.S. market. Year-to-date, the stock has increased 8.90% or \$2.56.

The stock with the second-largest percentage change for the week was ImmuCell Corporation (ICCC: NASDAQ), which decreased 13.50% or \$1.42. There was no news relating to the decrease for the week. Year-to-date, the stock has increased 52.94% or \$3.15.

Overview

The HSI was developed by Marie Kenney, while a student at Husson University, in consultation with Associate Professor J. Douglas Wellington. The HS tracks and analyzes the stocks of 29 companies that are considered to have an effect on the Maine economy. These companies are either based in Maine or have an influence on the Maine economy through employment or consumer spending. This price-weighted index offers a numerical breakdown of Maine's economy. The analysis looks into the events of the week and finds the likely reasons the

index went up or down. This index and analysis help provide a better understanding of Maine's economy as well as explain significant changes in stock prices of the companies that comprise the HSI.
