

SPOTLIGHT ON FACULTY









Professor Cornel Plebani (pictured above far left) has recently concluded an advisory position as a Criminal Justice subject matter expert for Pearson publishing. He also served as a member of the oral board for the Orono Police Department in their most recent search for a full-time patrol officer in October and will be collaborating with the 11th Civil Support Team (Weapons of Mass Destruction) to coordinate a full-scale exercise on the Husson campus in early November. He will be offering CJ 235 online this winter term for the first time.

Professor John Michaud (pictured above second from left) reviewed two new texts this year—"Criminal Law and Courts Encyclopedia," an overview of the Criminal Laws and Court Systems in various countries throughout the world, and "Criminal Investigations" which is intended for students in introductory criminal investigation courses. Professor Michaud will also be the key speaker at the first Oceanside Jobs for Maine Graduates Installation Ceremony in November. He will be offering PL 200 again this winter term online.

Professor Alicia Wilcox (pictured above second from right) presented at the National Institute of Justice (NIJ) Impression and Pattern Evidence Symposium (IPES) in Clearwater Beach, FL in August on changes in footwear conclusions. She also started her PhD in Forensic Science with Strathclyde University, Glasgow, Scotland. She hopes over the next 4 years to research how jury members interpret scientific evidence. She will be offering CJ 225 again online this winter and introducing CJ 101 online for the first time during the winter session.

Professor Margaret Campbell (pictured above right) joined the School of Legal Studies full time this fall after having taught in the Paralegal Studies program since 2004. She has begun a project with her ADR students to create a University Ombuds Office. This office would confidentially assist in the resolution of student concerns while giving the students experience as mediators. She will be supervising paralegal interns over the winter term at a variety of locations.

BAR FIGHT SIMULATION

Officers from the Orono, Bangor, and Hampden Police Departments showed students how to deal with violent situations in an Introduction to CJ course in October, 2012. "Students responded to a bar scene fight, which was choreographed. It gave them some tools to go in and deal with problems in the future," said Orono Police Sergeant Scott Wilcox.

Professor Cornel Plebani said, "We tend to see very high value for the incoming students to have very early application based and experiential learning opportunities so that we can take what we're giving them in terms of classroom based learning, reading and textbooks, and can begin to incorporate that into real world scenario based training and role playing." The students involved found it easy to become fully immersed in the role playing experience. Justin Carter says, "You do get a little lost in the movement but you always need to be able to come right back to it. They got to see how out of control it can get."



PHARMACY ROBBERY PREVENTION

The Pharmacy and Criminal Justice students were provided an in-service course coordinated by the School of Legal Studies, the School of Pharmacy and the Brewer Police Department in order to help combat the growing problem of pharmacy robberies in the area. Officers from Brewer Police Department and Director Marie Hansen shared their insight in handling those situations October 26, 2012. Officers say there have been over 45 pharmacy robberies in the state this year.

"It's a great deal of concern because anytime you have people with addictions they are unpredictable," says Perry Anton, Director of Brewer Public Safety. The students learned safety procedures to follow during a robbery, as well as skills to provide the best description of suspects.
