Student Email

All financial aid communication will be through the student's Husson provided email account. Returning student offer letters are emailed to your Husson email account. All communication will be directed to the student.

Privacy and Security

As part of federal requirements, we may be requesting confidential information from you, such as tax returns and copies of W2s. In order to keep your personally identifiable information secure, you have the ability to upload your documents directly to us using your Student Portal. You can also securely fax your documents to our office at 207.992.4930.

Emailing such documents is not a secure submission method.

Winter and Summer Session

If you will be taking winter or summer session classes, please contact the Office of Financial Aid once you have registered for the classes. Please note to receive financial aid for summer classes, you must be taking at least 6 credit hours as an undergraduate, and 3 credit hours as a graduate student.

June 17, 2024 Priority Paperwork Deadline

Financial aid will not be disbursed to your student account until all required paperwork, including verification documentation, is received and processed. For your financial aid to be reflected on your July 1st billing statement, all documents listed on your financial aid offer letter must be received by June 17th. Please note that your financial aid is subject to change at any time due to a variety of factors.

Understanding Your Aid

- Federal Pell Grant and Federal Educational Supplemental Opportunity Grant (FSEOG) are offered to students based on financial need. Your financial need has been calculated based on the cost of attendance minus your Student Aid Index (SAI) from your FAFSA.
- State Grants are offered based on state guidelines. If you are eligible for a state grant, you will receive notification directly from your state of residence.
- Husson Institutional Grants (Eagle Grant, U&Husson Scholarship) are offered to full-time day undergraduate students based on financial need and can vary from year to year.
- On-Campus Residential Grant is offered to students who live on campus, based on calculated financial need.
- Endowed and Restricted Scholarships are funds generously donated by alumni and friends of Husson University and offered to students based on the donors' wishes.
- Federal Direct Loans are guaranteed student loans, with the Department of Education as the lender. For more information, go to studentaid.gov.
- Federal Work-Study (FWS) is an allocation that allows students to work on campus to earn a bi-weekly paycheck. Students who are not eligible for federal work study may still apply for on-campus employment. Visit the Student Employment page for more information:

Tuition Payment Plan

Education expenses are easier to pay when spread over predictable, interest-free monthly payments. This option, offered in partnership with **Nelnet Campus Commerce** for a small fee, is an alternative to large annual or term payments and helps limit borrowing. Enrollment & Academic Standing

Generally, you must be enrolled at least half-time (6 credits per semester for undergraduates or 3 credits per semester for graduates) and matriculated in a degree program to be eligible for financial aid. A change in credit hours may cause a reduction in aid eligibility.

Most merit scholarships require a 2.5 or higher GPA in order to maintain eligibility.

Withdrawals

If you withdraw from school any time after the first day of classes, your financial aid will be adjusted according to federal guidelines. Withdrawal from a single course after the add-drop period will not result in an adjustment to your award as you will be billed the full cost of the class.

William D. Ford Direct Loan Entrance Counseling and Master Promissory Note


Every student who accepts Federal Direct Loans as part of their financial aid offer is required to complete the Master Promissory Note (MPN) and Entrance Counseling if they did not borrow at Husson last year.

To complete this process please follow the instructions below:

- 1. Go to www.studentaid.gov, and log in using your FSA ID.
- 2. Click "Loans and Grants," then click "Loan Entrance Counseling."
- 3. Select Husson University as the school for which you are completing counseling.
- 4. Click "Notify this School."
- 5. Click "I am completing entrance counseling to receive loans as an undergraduate/graduate student."
- 6. Once you complete the Entrance Counseling, click "submit counseling."
- 7. Click "Loans and Grants," then click "Master Promissory Note" (MPN).
- 8. Click on Subsidized/Unsubsidized/PLUS.
- 9. Select Husson University as the school for which you are completing the MPN.
- 10. Enter references and review loan agreement.
- 11. Select the certification box under "promises" and type your name under "sign and submit."
- 12. Click "Submit."

Comprehensive Fee: Students taking 9 credits or more will be charged a comprehensive fee of \$1,032/year. Students taking 6-8 credits will be charged \$690/year. Students taking 0-5 credits will be charged \$260

Program Fees: Undergraduate: NESCom \$1,092/year; 3-year Nursing \$1,248/year; Nursing \$832/year

Graduate: Counseling \$250/year; Nursing (MSN) \$762/year; Occupational Therapy \$436/year; Pharmacy \$1,310/year; Physical Therapy \$568/year

Residence Halls: Students who live on campus will be charged between \$12,682^{+/-} and \$15,854^{+/-} per academic year depending on room type and meal plan.

Books: Husson University recommends that students budget \$655^{+/-} per semester for books, though costs will vary
