

As I write this letter, the daffodils planted last fall during the Inauguration Ceremony are now in full bloom. I would like to thank you once again for a memorable ceremony and the support I have received since taking on the role of President.

In my last letter, I shared that an important initiative of the University is to strengthen our experiential learning opportunities to provide real-life, hands-on approaches to learning that will enhance our students' global understanding. Recognizing the importance of this objective and our need for space in which to achieve this objective, the Trustees have approved the construction of a new \$11.5 million campus Living and Learning Center. The Center, slated to be constructed by the summer of 2012, will enable us to provide new experiential learning classrooms that are greatly needed by our programs.

Boat School Closes

After much consideration, the Husson Board of Trustees has announced that the University will cease to operate the Boat School in Eastport by the end of the 2011-2012 year. After the University assumed responsibility of the Boat School three years ago, enrollment steadily grew from just two students to thirtyfour. "It has become clear that

without further significant investment in nearby industrial opportunities the Boat School will not be independently viable," said Husson President Robert Clark. "State support for Washington Academy's boat building program has been jeopardized and could adversely affect future enrollments. In addition, the City has made it clear that it can no longer bear the costs of facility operations and that we would need to assume those operational costs."

College of Business

The Board of Trustees of Husson University has approved a new organizational structure for the School of Business. The new College of Business consists of four schools within the College. In addition, the University has unveiled a new Master of Business Administration program. The comprehensive program focuses on enhancing professional business education offerings for Maine and Northern New England. For more information, please see the article featured in this issue.



Lee Speronis, J.D., a Certified Hospitality Educator will head the new School of Hospitality, Sport, and

Tourism Management within the College of Business. Speronis holds a doctorate degree in law from Stetson University and has won multiple awards in hospitality. He is active in his community serving on the Board of Directors of the American Folk Festival and Greater Bangor Region Chamber of Commerce.



Former Husson University President William Beardsley has been appointed commissioner for the Department of Conservation for the State of Maine. Dr. Beardsley will oversee the natural resource agency that manages, develops, and protects 17 million acres of forest land, 10.4 million acres of unorganized territory, 48 parks and historical sites, over 480,000 acres of public reserved land, and more. He currently lives

with his wife, Betsy, in Ellsworth.



Tom Collins has been appointed manager of the Sport Management program. He has an extensive background in

college athletics administration, having served as athletic director at Campbell University, sports information director at Coastal Carolina University, and assistant commissioner of the Big South Conference.

School of Science and Humanities

The School of Science and Humanities is expanding its General Education programs in the arts, which now include courses in digital photography, printmaking, drawing, painting, watercolor, pastels, modern and ballroom dance, and art history. Foreign language courses now include Chinese, Farsi and Arabic. In addition, a collaborative effort with NESCom allows for Husson students to take classes in acting, the history of theater, and the history of journalism.

Taking Care of Business: Investing in the Husson Reputation

Dr. Ron Nykiel, Dean of the School of Business, is once again revitalizing a brand, a task that has become something of a specialty for the new Dean. This time, Dr. Nykiel and his team are making meaningful changes within the College of Business. The improvements go beyond a name change, new signage and advertisements. A reorganized College structure, additions to the curriculum, and a Collegewide commitment to experiential learning are the first steps to repositioning the College of Business for future expansion.

Restructuring for Growth

In the national media, the term "restructuring" has been applied to lay-offs, closures, and reductions in services caused by the economic recession. At Husson University, restructuring the College of Business is good news, translating to growth and new opportunities for students, faculty and alumni.

The first and most obvious change is the name; from School of Business to College of Business, with four schools within the College. The four schools under the new College are: the School of Accounting; the School of Business and Management; the School of Hospitality, Sport, and Tourism Management; and the School of Legal Studies.

"Each school has a direct responsibility for developing specific programs," explained Nykiel. "The new structure allows each school to grow in its own respective academic area as well as provides greater opportunities for development, and corporate and community relations."

The restructuring of the College of Business takes root in the University's assets, built over 100 years of offering business education. "We are creating the structure and curriculum that encompass best practices from decades in business and education, and address rapid changes in marketplace demands," said Nykiel. "As the market changes, our programs will adapt to meet the needs of business professionals."

Doors have already opened to new opportunities within the School of Hospitality, Sport, and Tourism Management. Marilynne Mann recently joined the faculty and will be teaching as well as developing the tourism curriculum. Mann joins the Husson faculty after serving as interim director of CenTRO, the Center of Tourism Research and Outreach at the University of Maine. In addition to expanding Husson's program with a new Tourism Management major, Mann will help create a Research Institute for Tourism to serve businesses in Maine and provide learning and research opportunities for students.

The College of Business will soon welcome Nancy Foster Holt, who will help guide the final stages of developing a new major in Entrepreneurship. A third new major in Business Communications calls for collaboration between the different schools, in-



corporating courses from other Husson University programs. All three new majors – Tourism Management, Business Communications, and Entrepreneurship – are expected to be approved by the Husson Board of Trustees in time for offering the appropriate courses of study in 2012.

On a regional level, Nykiel envisions expanding Husson's offerings and operations in Portland and Presque Isle as well as other locations. "One logical expansion is offering both Business Communications and Tourism and Hospitality at our site in Southern Maine at South Portland," Nykiel explained. "Likewise, the College of Business could make natural connections to our site in Northern Maine at Presque Isle through our Tourism programs."

Challenging Curriculum

New majors, though important, are not the biggest news coming from the College of Business. Husson University recently launched a new MBA degree with concentrations in Corporate Management, Health Care Management, Hospitality Management, and Non-Profit Management. The new MBA degree program replaces the University's MSB degree, and Nykiel envisions

further enhancements to the curriculum.


"We're looking at every course in the MBA program, looking to provide increased rigor while adding new courses," noted Nykiel. "For example, we are making foreign languages beyond French and Spanish available as electives, responding to emerging global markets."

Nykiel notes that the first semester of Mandarin was offered in fall of 2010, and "we filled every seat in the class." This fall (2011) the College is offering the second semester of Mandarin focused on business protocol, helping students move beyond the conversational language to the language of business. Other languages offered this fall include Farsi and Hindi, both considered to be among several "critical languages" by the US government. Nykiel's plan calls for offering students the choice of at least two to three of the top six critical languages during the course of the school year.

In addition to expanding foreign language studies, Nykiel aims to make experiential learning a focal point of every program within the College of Business. "Experiential learning sets Husson apart from other schools," stated Nykiel. "The experiential learning opportunities are hidden assets; not every university will offer its students the first-hand, real-world opportunities we provide at Husson."

For example, the Dyke Center for Family Business is now run by teams of students. Sales, pricing, events, and daily operations are managed by students, with supervision from Lee Speronis, J.D., the new Director of the School of Hospitality, Sport, and Tourism Management.

The School of Accounting also enjoys 100% placement in experiential learning, with every degree student placed in an internship before graduation. In the School of Legal Studies, the Criminal Justice students



often work with the Orono Police in simulated situations, where police officers play the role of students, and students take on the role of law enforcement.

"The goal is to offer the most diverse and relevant experiential learning you can get," stated Nykiel. "Industry wants someone who not only studied the job, but a person who, through experience, can perform the job."

Shifting Gears: from Internal Changes to External Connections

A vision for change and renewal just six months ago is now becoming a reality, thanks in part to the willingness and creativity of the faculty and a supportive administration. The next six months will bring additional opportunities to the College of Business, with the intention of maintaining the momentum created by recent changes.

"We have the evidence that rebranding and restructuring the College of Business is working," stated Nykiel. "Enrollment is up in all programs. The number of applicants has increased, including transfers from other MBA programs. The excitement is catching."

Beyond the internal measurements, other factors indicate that change is good for the College of Business. Support and inquiries for internships have increased dramatically, as has interest in articulation agreements with Maine's technical schools.

"As we rebuild the identity of the College of Business and Husson, we rebuild our core strength," explained Nykiel. "We have so many alumni in prominent positions – leaders in their industries – but we've done little to increase our own visibility in the competitive market of higher education."

The plans call for keeping the College of Business in the media; Nykiel is finding ways to create headlines and connect with the community, including Husson alumni and supporters. The new Dean's Distinguished Lecture Series is one example of how Nykiel is making those connections. In late April, the School of Legal Studies welcomed noted Legal Lecturer F. Lee Bailey, defense attorney in several notable cases including the O.J. Simpson trial.

"The goal for the advertising campaign and Dean's Distinguished Lecture Series is to reach beyond the traditional primary market for Husson and bring more diversity to the University," said Nykiel. "We hope to present as many perspectives as possible, not only through a variety of speakers, but a diversity of students."

Despite the fact that Husson's College of Business is now the largest in Maine with 1,400 students, the hallmarks of a traditional Husson education remain. There are no plans to change what is most important at Husson University.

"The culture of Husson University is one of respect and caring for each other," said Nykiel. "Both students and faculty define a culture and a way of life – a good life – that defines Husson."

Paul LePage: From Homeless to Husson to Governor

Governor Paul LePage '71 is an unlikely success story. The oldest son of 18 children in an impoverished French-Canadian family, he ran away at age eleven to escape from his abusive parents, and lived on the streets of Lewiston, Maine for two years, working for spare change as a shoeshine boy.

When he was 13, his luck improved slightly when two families jointly "adopted" him. They gave him an opportunity to work, and encouraged him to go back to school. Even so, college seemed out of the question: LePage had grown up speaking French and his English comprehension was poor, so he'd received a low score on his SATs. On top of that, he didn't have any money to pay for a school's tuition. After graduating from Lewiston High School in 1967, he applied to more than 40 colleges, and was rejected by all of them.

LePage wasn't willing to take no for an answer, though. He set his sights on Husson University, and began calling college officials to find out if there was anything he could do to get a second chance. He managed to line up a personal interview with the school's

President, Chesley H. Husson, Sr., and was admitted with two conditions: He had to take an achievement test in French to prove that he was smart enough to attend, and he would be on academic probation. If he didn't get good grades, he wouldn't be allowed to stay.

Money was another issue, but fortunately, State Senator Peter Snowe—the late husband of Senator Olympia Snowe—was also willing to take a chance on the determined young man. Senator Snowe paid the bill for his first year's tuition, with the condition that "I needed to work as hard as I could," says LePage.

LePage began a major in business administration in 1968, and, after completing his successful first year of college, he obtained a combination of loans and scholarships to continue

his degree. He paid for living expenses with part-time jobs as a short-order cook and a bartender.

As well as working, studying, and attending classes, he found time to get involved in extracurricular activities. "I was the editor of the weekly newspaper, The Spectator," says LePage. He also got his first taste of the political life at Husson: "I was a member of the Student Senate, and president

of my class," he says. "We worked to bring events like concerts, plays, and speakers to campus, which hadn't been done before."

LePage credits the education he received at Husson as "a driving force" in his life. "It built character and gave me a good foundation to go into the working world. I've competed against people from Harvard, Yale, and every top school in the country, and the education at Husson is enormously competitive."

In particular, he has fond memories of Clara Swan, who taught at Husson for decades and served as academic dean during LePage's time there. Swan, now 99, is the namesake for the Swan Center athletic facility; she still attends basketball games at the school. "She was one of the major influences in my life," says LePage.

He also admires a former teacher, Professor Phil Grant, who recently retired from Husson after a 40-year career. "He was real tough, but you learned a lot," he says.

After graduating from Husson, LePage went on to earn an MBA from the University of Maine. He worked as an executive in the lumber and paper industries until 1983, then lost his job after turning down a promotion that would have taken him out of Maine. That led him to start his own consulting firm, helping troubled companies to regain financial health. He also returned to Husson as an

LE PAGE | continued from previous page educator, teaching courses in finance, accounting, and ethics.

In 1996, LePage was chosen to work as general manager of the discount chain store Marden's, where he helped to grow the company's revenues and size by more than 100%. Building on his successful business career, LePage,

a Republican, decided to become involved in local government: In 2004, he completed a successful run for mayor of Waterville, and kept that position for six years. And, in 2010, he became the dark horse winner of Maine's hotly

contested governor's race, beating his closest opponent, Eliot Cutler, by less than 10,000 votes. He selected Bill Beardsley, Husson's former president, to serve as the commissioner at the Maine Department of Conservation.

Since the election, LePage has been focused on shaking up the establishment, and his outspoken

and often controversial viewpoints have already made him a staple of the national media. His gubernatorial agenda is focused heavily on cutting back government regulations, with the goal of creating a more inviting atmosphere for businesses in Maine.

LePage's journey from homeless youth to governor was a difficult path, but he believes that the skills he learned at Husson fueled his road to success.

"My advice to today's Husson students is to study," says LePage. "Become a sponge and learn everything you can possibly learn because education is power. The more knowledge you have, the better decisions you will make later on. That's one thing people can't take away."


Dean's Lecture Series Brings Renowned Speakers to the Husson Campus



Matthew Mulligan: NFL Player Got His Start at Husson



As a tight end for the New York Jets, Matthew Mulligan, 26, has logged countless hours on the football field in recent

YEARS. But back in 2003, when he came to study at Husson University, he'd never played the game in his life.

Mulligan was no stranger to sports, though. "My first love was basketball," he says. Growing up in the small town of Enfield, Maine, he played on the soccer and basketball teams at Penobscot Valley High School. His high school hoop skills helped catch the eye of Husson's basketball coach, Warren Caruso '89 '08, who recruited Mulligan to attend Husson.

Getting his college acceptance letter was a proud moment: Mulligan was the first member of his family to attend college, and he vowed to make the most of the opportunity. Mulligan

enrolled with a double major in physical education and business, and a guaranteed spot on the basketball team.

Before long, he had even bigger goals: He wanted to play football, too. Mulligan's high school was too small to have a football team, so he'd never played the game before. People had often told him he was big and strong enough to be a football player: Mulligan is 6'4, and weighs 265 pounds.

So after attending a few football games and cheering on the team from the sidelines, Mulligan decided he wanted to be part of the action. "My biggest driving factor was the fear of regret," says Mulligan. "I didn't want to look back years later and wish I'd played when I had the chance."

At the start of his sophomore year, he tried out for the Husson Eagles, and was given a spot as a tight end. Mulligan immediately bonded with the football team—in particular, his coach, Gabby Price, who spent seven years as the Husson Eagles football coach and retired in 2009. "He's always been compassionate and understanding," says Mulligan. "He allowed me to grow up and be a man without pressuring me to be someone I wasn't, not just in football but in life. I consider him to be like family."

It didn't take long for Mulligan to realize that he had a special talent for the sport. "It was never my plan to reach the NFL," he says. "But after I'd played one year at Husson, I'd developed pretty solid skills as a tight end."

Mulligan decided to transfer to University of Maine Orono in 2005, where he began playing on the school's Division 1A Black Bears football team. Before long, NFL scouts began showing up at practices. "At that point, I realized I had a real opportunity," says Mulligan.

He's made the most of it: In 2008, he signed a contract with the Miami Dolphins as an undrafted free agent, and served on their practice squad until November that year. The Tennessee Titans then signed him to their practice squad until September 2009, when he was recruited by the New York Jets. After playing on the practice squad for several months, Mulligan was promoted to the active roster. He played in five games in 2009 and 13 in the 2010 season, helping the Jets achieve a winning season record of 11 to 5.

Although Mulligan now lives in New Jersey, near the Jets' new 120,000-square-foot state-of-the-art practice facility in Florham Park, he hasn't lost touch with his Maine roots. He still makes regular visits back to Enfield to see his family and spend time fishing and hunting—and he contemplates returning to the state for good one day.

Still, he plans to play in the NFL for as long as he can. "I will play football as long as God lets me and as long as somebody wants me," he says. "You take it day by day, and nothing's guaranteed."

When his football career is over, Mulligan is considering a variety of career options: an investment banker, a hospital administrator, or maybe even working as a game warden in the Maine woods. There's a steep learning curve for all of those jobs, but Mulligan has already proven that he's a pro at learning on the fly.

No Small World of Learning Opportunities

Notable Alumni Earl Goodyear '69

Earl Goodyear '69 is a true humanitarian, a label his sense of humility might not allow if he were to edit his biography. Earl most often talks of others who have influenced him and lessons learned from other cultures; rarely does he speak in terms of his own, noteworthy accomplishments. Earl does not, in fact, consider himself a "notable alumni."

But notable he is, having most recently returned from an assignment with the United Nations Development Program and the Lao National Disaster Management Office. Earl's was no small job: to draft a National Disaster Management Plan as well as the national legislation to give strength to the new Plan. This latest assignment is not the first time a global organization has utilized Earl's thirty-five years of experience in international relief and development. Earl's expertise as an advisor and specialist in disaster management, mitigation and recovery is sought by national governments and disaster response organizations throughout the world.

Earl's career has taken him from Africa to Egypt, Pakistan, and Indonesia, and numerous stops in between. At every destination, Earl has embraced the opportunity to learn something from a country's culture and people. "I've been keeping a diary of my travels for twenty years," said Earl. "With every new place to see, I can pick out something I learned for the first time."

He believes his curiosity of cultures, history, religion and languages began during his college years. "At Husson, I had the opportunity to meet and interact with foreign students," explained Earl. "In my junior year, my roommate was from Thailand. He and other foreign students sparked an interest to visit other countries."

His first move immediately out of school was to the West Indies, working as a Fisheries Advisor for the Peace Corps. "I knew I was going to be engaged in humanitarianism, but I wasn't certain about my career focus." Given his first challenge in humanitarian aid, "I was quickly able to find solutions to the challenges for a small community, including a financial plan that put them in fishing boats. Husson gave me the business skills to help those families. Husson gave me the skills and aptitude for any challenge."

Earls' career has crossed paths with earthquakes, hurricanes, floods and human conflict. The numerous challenges have been met with a skill set Earl also credits to his mentor at CARE International; "In order to do the work we do, you must have patience, perseverance and a sense of humor." Earl noted.

"There's no blueprint or rubber stamp for disaster or risk reduction," explained Earl. "All cultures are different, and some cultures are more deliberate and move slowly. Instead of trying to move rapidly, I encourage the changes that will transform the development process over time."

When asked about the most memorable destinations, Earl's thoughtful response has very little



to do with disaster management. On his first trip to Laos in 1972, Earl was "awestruck by a very tall, young lady" standing among a group of women. "Her radiance stunned me," said Earl. "I didn't know who she was, but I said, 'I'm going to marry her.'" Bouakham (which translates into Golden Lotus) and Earl were married in 1973, and "the love of my life has raised two children and cared for me for the past 38 years on four continents."

What's next for the world traveler and problem-solver? "It's time to put my passport aside for time with family and friends," at least for the foreseeable future. The British government recently asked Earl to go to Libya, "but my current assignment conflicts with that request."

Notable, indeed.

Keeping the House in Order

Notable Alumni Heather Priest '98 Delta Sigma Delta Maine's New Clerk of the House of Representatives

Rarely is there a "slow" day in the Maine House of Representatives. Every day is a busy day in the State's largest legislative chamber. Some would find the daily challenges stressful, but Heather Priest '88 "loves it."

Heather, a 17-year veteran of legislative service, was sworn in on December 1, 2010 as the new Clerk of the House of Representatives. She serves as the chief executive and administrative official managing the daily operations of the House. In practical terms, that means everything from budgeting and staffing to oversight of the House calendar, journal and other official documents.

"My job brings new challenges every day," explained Heather, who oversees a staff of more than 20 people who accomplish the broad range of administrative, managerial and parliamentary tasks. Currently the House consists of 151 members plus two nonvoting members representing the Penobscot Nation and the Passamaquoddy Tribe.

Before being elected as the new Clerk, Heather served as a senior legislative aide. The majority of Heather's former responsibilities involved constituent work, helping people navigate through the maze of state government.

"I enjoyed helping legislators and their constituents work through everyday problems," explained Heather. "As a legislative aide, I might have helped someone with a business matter one day, such as obtaining a professional license; and the next day I would be assisting someone with a child support issue."

Heather's professional experience mirrors something she values most about her time at Husson. "There were a lot of people working to help students make their way through college," Heather noted. The smaller college attracted Heather because "students can get as much individualized attention as they want and get to know just about everyone on campus."

Many of Heather's favorite Husson memories are tied to Delta Sigma Delta, their advisor and special friend Joyce Goodine '66 '92 '95, and the group of sorority sisters she sees twice a year at gettogethers in Bridgton.

"It's a special commitment from everyone, but it's one of the few things that we all – even our kids – look forward to every year," said Heather. "We started these gatherings before our children were in school – and many weren't even born yet. The oldest of the bunch graduated last spring and a couple more will move on to college in the fall. We all feel very fortunate that we've been able to keep this tradition going year after year."

When asked what Heather would say to a student considering Husson University, the response came easily; "Husson is a great school with tremendous opportunities for students beyond the academics. Husson helps prepare students to be productive citizens, learning as much outside of the classroom as we did from our instructors and mentors."

Heather originally chose Husson for its court reporting program and began working immediately after graduation as a court reporter in Portland. While at Husson, Heather met her husband, Keith, and the two will soon celebrate their 21st anniversary. Heather and Keith live in Augusta with son Keith and daughter Maggie. Between family, volunteer work, and a new job, Heather's days are full to overflowing.

Whether it's planning the swearing-in ceremony for Maine's constitutional officers, helping with Franco-American Day at the Legislature or coordinating Welcome Back Day for former House members and staff, Heather takes it all in stride.

"At the start of session one day before an unusually large crowd someone asked me if I was nervous. It took me a minute to realize that I wasn't." Heather shared. "I know that every day in the House of Representatives is a memorable day."

Campus Expansions on the Horizon

To meet the needs of an ever-growing institution, the Husson Board of Trustees has approved two major campus construction projects that are slated to begin this summer.

As the University's enrollment climbs, both academic and living spaces are nearly bursting at the seams. The \$11.5 million Living and Learning Center, slated for completion in August of 2012, is designed to meet these needs in a way that is not only cost effective, but provides students with a unique, holistic learning environment. Renovations to the Dickerman Dining Commons will ensure the facility is able to meet the needs of the additional on-campus students resulting from the addition of the Center.

"As our enrollment continues to increase, this is the natural next step in our growth," said Richard Trott '65 M Σ X, Chairman of the Board of Trustees. "This multi-purpose building will help not only with our housing shortage, but will fully enhance our campus life."

The building will showcase experiential learning classrooms dedicated to specific academic programs. Experiential learning has become a major component to the program curricula, providing an opportunity for students to connect the theory learned in lectures to real-life practice, which, alongside internship and clinical experiences, better prepares students for professional careers. Experiential learning space in the Living and Learning Center will provide the College of Business with space to conduct simulated board meetings and web-based team











analysis. Students in the School of Legal Studies will use the classrooms to investigate mock crime scene scenarios which will be integrated across academic programs.

"We are excited to be able to expand on our ability to provide state of the art experiential learning centers to further enhance program development in areas such as in business and criminal justice," said Dr. Lynne Coy-Ogan, Husson Provost. "Just as students in our School of Nursing have access to cutting-edge simulated lab facilities, these spaces will allow our faculty in other disciplines to have their own dedicated experiential learning environments."

The Living and Learning Center will also meet the dire need for more housing. The additional 245 beds included in the four stories of suitestyle living spaces will provide enough housing to allow more of Husson's students the opportunity to live oncampus. Each living "quad" will include two-student bedrooms, a shared living room space and a shared bathroom. This suite-style residential living space, which is becoming the new standard in campus living, will provide more space and privacy than Husson is currently able to offer. Each floor will have a general lounge space where students can study, watch television and movies, or hold meetings and small gatherings.

"With this combination of residential life, faculty offices and experiential learning centers in the same building, there will be wonderful opportunities for collaborative, hands-on learning, which are hallmarks of a Husson education," said Husson President Bob Clark. "Having the living space and the classrooms in the same building cultivates an environment conducive to the pursuit of academic and personal success. Long term it will provide space for visiting faculty and lecturers to provide students the opportunity for an even more holistic learning environment."

Dickerman Dining Commons

The University's Dickerman Dining Commons, which has served students since its construction in the early 1960's, has increased production from 200,000 to 300,000 meals per year. Additional on-campus housing will boost these figures even more, further stressing the need for an expanded facility.

The 10,000 square foot expansion will include a completely new kitchen and service area and a total renovation of the dining area including food stations, new seating and a tray-less flexible service style. The project is slated to be completed in phases, starting with the kitchen area.

May 2011 Commencement

The 112th Commencement Ceremonies were held on May 14th in Bangor. At the ceremony, 583 degrees were awarded to more than 500 students. Graduates represented 209 Maine towns, 19 states and 9 countries. The commencement speaker was the Honorable Governor Paul R. LePage '71.

The Honorable Governor Paul R. **LePage** received his bachelor's in business administration in finance/ accounting from Husson in 1971. Following his time at Husson, Governor LePage earned his master's in business administration from the University of Maine. Governor LePage became the 74th Governor of Maine on January 5, 2011. 
