Each eco-environment has its own people, plant life and animals; a stark reminder of the fragility of our planet."

Dear Friends,

This has been a great year. We matriculated 800 new undergraduate students into Husson and the New England School of Communications. Every part of the campus is filled to capacity. We are pleased to report that the College is in very good overall health. We also express our deepest appreciation to each of you for your generous and ongoing support.

In July, our new doctorate in pharmacy, the Pharm.D., was approved by the State of Maine. We are now moving towards professional association and regional accreditation approval. In August, Dr. Rodney Larson was appointed Dean of Pharmacy. Rod earned his Ph.D. at the University of Minnesota and comes to us from his position as assistant dean of pharmacy at Ferris State University in Michigan, one of the oldest schools of pharmacy in the nation.

The State also approved our proposed law degree, the J.D. We will now petition the Maine Supreme Court to gain authority for our graduates to sit for the Maine Bar Exam followed by regional approval. Robert Kuhn holds multiple law degrees and has served in senior positions in national corporations and at the Howard Hughes Medical Institute before joining Husson as Dean of Business. Rob will serve as our Founding Dean of Law. Subject to final accreditation approvals, we expect both programs to be fully approved and underway in 2009.

The College displayed financial strength during the fiscal year ending June 30, 2007. Net assets rose from \$33.1 to \$38.8 million or by 17%. Long term debt and balances on its line-of-credit declined by 15% to \$6.4 million. College reserves and endowments rose by 21% to \$14.5 million as of June 30th when compared to the year before.

Major outreach centers in South Portland and Presque Isle, Maine, continue to broaden their offerings. In addition, during this past year, Husson availed itself of two extraordinary opportunities to serve Down East Maine's Washington County. Philanthropists Sidney and Nancy Unobskey presented Husson with an outreach facility in Calais, Maine, where we now serve students on both sides of the U.S./Canadian border. Then, nearby Eastport invited Husson to take ownership of the Eastport Boat School. These sites are only now fully staffed and their full implementation will occur over the next academic year. They offer Husson degrees and certificates through what we now call Unobskey College.

As always, our Bangor campus continues to evolve. We have added new programs in teacher education and chemistry. A major part of the Penobscot County Law Library is now part of our expanding Tom and Bonnie Sawyer Library. The




College has opened our new, upscale Furman Student Center, Willey's Café complete with its Starbucks Coffee, and the Cressy Marketplace, located right in the heart of Peabody Hall. A new mobile production studio has been added to the New England School of Communications serving as a "live" learning studio for communications students. Our newest project is the resurfacing our international-style Boucher Soccer Pitch with artificial turf. The artificial turf will also enable Husson to add men's and women's lacrosse as spring sports.

Most exciting of all, the College has broken ground on the "Meeting House." This is a beautiful, 55,000 sq. ft. gathering place. It includes an academic wing, the Cyr Alumni Center with its Husson Archives and, "Gracie Theater", a 500 seat state-of-the-art, and balconied performing arts theater. Our lead gift is in place and our campaign is underway. Your support and generosity is needed and we invite you to become involved. Finally, as our numbers of traditional undergraduate students soar past 2000 this fall, additional academic space, housing and parking are very much under consideration. These are exciting times. And so many of these accomplishments are thanks to you.


Along with so much good news come challenges. With a downward trend in the number of 18 year olds throughout New England over the next decade Husson is challenged to strengthen its brand, expand its geographic markets and market penetration, and improve its well deserved "value added" reputation. Capital improvements and expansions come at a heavy capital cost and the college must strategize carefully to assure costs do not exceed revenues. However, on the revenue front, our ability to raise pricing is constrained not so much by competition as by our commitment to remain affordable to Maine students. Husson's retention and graduation rates continue to improve as the College still strives to lose fewer students along the way. These issues are very much on our minds as we strive to improve.

In closing we bid farewell and thank you to long time Board member Norman Kominsky. Norm served the College for over a quarter century, including three terms as Chair of the Board. We miss Norm and thank him for his outstanding service.

Husson dreams big under President

BANGOR, Maine — When William H. Beardsley became president of Husson College in 1987, he ordered an odd and expensive change to the campus, one that raised a few eyebrows.

“The first thing he did was pave all the roads,” Julie Green, spokeswoman and 27-year employee at Husson College, said in a recent interview. It was a symbolic move, intended to send a message of optimism to the staff, she said. And it was the first of many significant changes.

The school, known locally as “Husson High” in the 1980s, has undergone such a transformation since then that it might not be a stretch to call it “Husson University” today. And much of that change has been credited to Beardsley, a zealous entrepreneur who celebrated his 20th year as college president this month.

When Beardsley first arrived, Husson offered associate and bachelor of science degrees in business and nursing. The school was having difficulty keeping up enrollment, and over its

head loomed a debt of \$15 million. Husson hired Beardsley as its CEO in December 1986, hoping that his expertise in higher education and finance would alleviate some of its problems. Seven months later, Beardsley became president, and, to the surprise of staff, he began spending, adding new buildings and programs almost immediately.

“We didn't fully understand what he was doing at the time,” Green said. But Beardsley had a strategy.

“Filling it [Husson] to capacity dramatically improved our finances,” Beardsley said in a recent interview in his office. New programs boosted enrollment, and by refinancing debt, aggressive fundraising, and keeping staff and campus expenses to a minimum, Husson balanced its budget, Beardsley said.

The campus paid for building projects as it could afford them, adding the Dyke Center for Family Business, the Peirce Webber Campus Center and the Robert

O'Donnell Commons, Beardsley said. Faculty and staff became used to working within a tight budget, and when one staff member griped about Beardsley's spacious wood-paneled office, he moved into a small cinderblock room in the basement of a freshman dormitory, across the hall from the laundry room.

Paul Husson, 67, a senior development officer at the college and son of the late founder, Chesley H. Husson, said his father's vision of a buzzing, intellectual campus is certainly alive today. Chesley Husson turned what was Shaw School of Business, a proprietary school, into a nonprofit, accredited college after he acquired it in 1926, Paul Husson said.

Husson's success at any given time usually can be attributed to its leadership, Paul Husson said.

“I think he [Beardsley] is quite visionary. He's very energetic, a very hardworking guy. It's hard

to keep up with him,” Husson said, laughing. “He’s the right person at the right time.”

The school’s offerings now include 27 undergraduate degrees, eight master’s degrees and two doctoral degrees. Its presence in Bangor, Portland and Caribou has expanded to South Portland, Presque Isle, Calais, Eastport and Vassalboro.

The acquisition of the New England School of Communications, a wholly owned subsidiary of Husson, in 1997 also has boosted enrollment. Bangor Theological Seminary moved onto the Husson campus last year but remains entirely independent.

Husson now has a firm standing in Washington County, where it plans to use the Unobskey College in Calais as a satellite campus. Husson also plans to begin running the Eastport Boat School later this year.

Just this month, the State Board of Education authorized Husson to establish a law school, which now awaits approval from the Maine Supreme Judicial Court. And last month, the board approved a doctor of pharmacy program at Husson. The college plans to begin its three-year undergraduate pharmacy program this fall and then introduce the three-year graduate pharmacy program in 2009.

To those looking on, Husson’s growth might seem rapid, Beardsley said.

“There’s a perception that we’re going awfully fast. Some people think Husson lunges at everything,” Beardsley said. However, the board, faculty and staff have chosen its programs carefully, consulting heavily with state government, specifically the Department of Labor, to determine which programs are needed in Maine, Beardsley said.

“We are not just in Maine, we are of Maine,” he said. “We ask how we can position ourselves for what Maine will look like down the road.”

Beardsley describes Husson’s growth as having been “vertical, then

horizontal.” It first created a diverse stack of undergraduate options, adding programs such as education, criminal justice and psychology, then spread laterally to introduce master’s and doctoral degrees, he said.

Husson has learned that in order for a new program to be successful, it must be welcomed by students. Beardsley gives as an example the science teacher education program it introduced in the late 1990s, when the state forecast a shortage of high school science teachers.

“Students who were interested in science didn’t want to become teachers. They wanted to be doctors, scientists, chemical engineers,” Beardsley said. As a result, the science education program has seen little growth, Beardsley said. It was an important lesson for the school, he said.

Enrollment has more than doubled in the past 20 years, growing from 1,081 students in the fall of 1986 to 2,356 students last fall. Of those 2,356 students, 2,074 were from Maine, 239 were from other states, and 43 students were international. After the Sept. 11 attacks, Husson saw a sharp decrease in the number of international applicants but hopes that group will become a larger presence, Green said.

Husson’s staff has doubled in the last 20 years, from 135 employees in 1986 to 272 employees in 2006. Many staff members have multiple titles, Green said. The 42-member faculty has grown to 65 members.

Husson’s athletic department became a member of the National Collegiate

Athletic Association Division III in 1998. Sports have become a significant attraction for prospective students and have put the school in the news, Beardsley said. The John Winkin Athletic Complex, with a football, baseball and field hockey field, was unveiled in 2003.

One reason Husson has been a popular choice for students seeking a private, liberal arts education in Maine is that tuition costs are relatively low. In the past 20 years, full-time annual tuition has increased from \$5,500 in 1986 to \$11,970 in 2007. Annual tuition increases have remained lower than the rate of inflation, Beardsley said.

The college has a liberal admissions policy, meaning it accepts most students who apply, but criteria have grown more specific for each program. Husson is committed to finding “diamonds in the rough” who have great potential to succeed as they mature, Beardsley said.

About 51 percent of students graduate in six years. Nearly 40 percent of the students who entered last fall were the first in their family to go to college, according to Green.

President Bill Beardsley, Board Chair Art Fuller and more than two dozen members of the faculty and staff were on hand to give presentations and answer questions about today’s Husson College. President Beardsley presented the “State of the College” in which he discussed the changes of the past 20 years, gave a financial report and discussed the vision for the future. Chief Academic Officer Rick Stephens, the academic deans and members of

the current faculty discussed the expanding world of Husson academics and new programs planned for the Fall of 2008 and beyond. The participants enjoyed a shore dinner and a presentation by Husson Vice-President John Winkin, and had a chance to get to know some of today’s Husson students.

This was the first of many Husson Today Summits planned by the Development Office and the Office for Alumni Affairs. These summits are designed to help foster our relationship with our alumni and identify others who want to be stay connected with Husson and be part of our future growth and success.



Remember when...

“I remember that day, June 12, 1966, like it was yesterday,” said Clara Swan. “Everyone from the College was there to share with Mr. Husson. He was so proud and we were all happy for him. People forget what he sacrificed to make this happen. There were seven of us who held shares of stock in Husson College and he asked each of us to give those shares back to him so he could make the college a non-profit entity. None of us even hesitated,” she said.

“It was a full two years after that day before we began to move to the campus. After having been located in downtown Bangor for so long it seemed strange at first, but everything was new and we loved it,” said Clara. “When I look at the College today I never would have thought it could become what it has but I know that Mr. Husson wouldn’t be at all surprised. He was a visionary. Mostly I’m sure that he would be proud.”

March 28, 2007 was a very special day for the students at Husson College. A day-long schedule of activities designed to celebrate the latest addition to the Husson campus included a formal ribbon cutting ceremony for the Ross Furman Student Center, Willey Café and Cressy Marketplace. The ribbon-cutting was held in the Furman Center in the early afternoon. Other activities included a delicious sushi bar hosted by Chuck Cressy and later a dance with the B.C. Rockers band from Portland.

The Furman Center is a 4,000 square foot facility designed solely with the students in mind. Pool tables, a ping pong table, video games, 8 flat screen tv's, a sound system, stage and lights make up a room where the students can enjoy a snack, play a

game with a friend or settle back to watch a little television. Weekends find the Furman Center home to dances, comedy shows and parties to help the students relax and unwind.

Ross Furman graduated from Husson in 1972. A native of Eastport, he is currently the owner and CEO of Skillful Vending and also the owner of multiple properties located in the Bayside area of Portland. "I wanted to return something to Husson College because it got me on my way," said Ross. "I cannot think of a better place for me to help out than for this gift of a student lounge and recreation center. After all, recreation is my line of work!"

The Cressy Marketplace is a full-service dining area and "corner market" that sells food items to the Husson community. Open Monday thru Friday from 7:30 a.m. to 9 p.m. it is a popular gathering place for students and staff alike.

Made possible by a generous donation from alumnus Chuck Cressy the Marketplace is a beautiful addition to our campus.

Chuck Cressy is the owner of Durham Marketplace in Durham, New Hampshire. After graduating

from Husson in 1973 with a B.S. in Business Administration, Chuck moved from a management trained position with Hannaford Brothers Company in Scarborough, Maine, to operating his own store, Durham Marketplace, where he began to offer more natural foods and specialty items. The needs of his clientele were not only met, but exceeded. In recent years, the addition of the sushi chef within the store has been a success and led him to establishing his own sushi company. In 1998, Chuck was honored for his efforts by receiving the New Hampshire Grocer of the Year award.

The Willey Café is home to the Starbucks franchise. Famous for their coffee, the Café also offers a variety of specialty sandwiches and morning pastries. The café is named for well-known area businessman Lloyd Willey, president of the Canteen Company headquartered in Bangor. Athletics 2006-2007 Results

Success on many levels



The 2006-07 school year was a great one for Husson athletes. Not only did they excel on the field, but in the classroom as well.

Nine student athletes earned a perfect 4.0 g.p.a. during the spring semester. More than half of our student athletes earned a g.p.a. above 3.0 with 51 athletes earning high honors of 3.5 or above. The combined g.p.a. for female athletes was 3.06 while the men earned a 2.81. "We are just thrilled with the effort our student athletes made in the classroom this past academic year. We have an incredible group of young people involved in our athletic programs. Their effort both in the class room and on the playing field make us very proud of what we are doing," stated Athletic Director Gabby Price.

The 2006-07 season was led by the Golf and Women's Soccer teams winning North Atlantic Conference titles and advancing to NCAA III

tournaments. Men's basketball had an undefeated conference record and earned their regular season conference title. The football team finished at 6-4 with an impressive win over Division II LaSalle University.

Baseball finished at 7-5 in the NAC, Field Hockey at 6-2 in the NAC, Softball finished at 8-2 and Volleyball went 5-5 on the season. Women's Basketball went 11-6 and just missed a playoff bid. Women's Swimming finished 6th in the GNAC Championship.

Husson had 37 athletes recognized by the NAC as All Conference or All Academic. There were Three Eagles named Rookie of the Year and two coaches earned Coach of the Year honors. Three Eagles gained regional attention. Brian Biggers, Football, Orlando, Florida, was named All New England Division II/III. Shelby Pickering Bradford, Soccer, Lee, Maine, was named Division III 2nd team All-American, and Nick Henry, Penobscot, Maine, Basketball, was selected to the NABC Honors Court.

"This past season was a success on many levels. We had tremendous success in the classroom, two programs competed at the NCAA National tournament, and our programs are close to the top in the conference." Athletic Director Gabby Price says in wrapping up the year. "These successes, along with our student athletes being recognized not only on a conference level but also on a regional and national level, have given Husson a lot to be proud of."

Congressman Michael H. Michaud May 12, 2007



Michael H. Michaud is a product of the Great Maine Woods. He serves as a United States Congressman, representing Northern, Western, Eastern and Central Maine. He is the first recognized Franco-American from Maine to be elected to federal office.

Michael Michaud was born and raised in Medway, Maine, the second oldest of six children. He loved to fish, he took in stray animals, worked his way through high school pumping gas, and, upon graduating from high school, started his thirty-year career with Great Northern Paper where, to this day, he remains a member of USW Local #4-00037. He remained close to his family, knew everyone in town, worked with his high school classmates and held down a secure union job. It was a good career for life. But in most lives there is a tipping point and, for Michael Michaud, it was the polluted cove of the mighty Penobscot River that he looked at every day. At the age of twenty-two, he simply realized that someone had to find a way for the jobs and natural environment he loved to thrive together.

Michael Michaud was elected to the Maine State Legislature when he was twenty-three. He first served in the House of Representatives where his greatest pride lay in the passage of the river reclassification and toxic use reduction legislation and the Growth Management and Products Act, speaking out for the interests of his extended family, his community, company and fellow workers. With growing influence, he was elected to the Maine State Senate, becoming Chair of the Appropriations Committee and then President of the Senate. He became a renowned champion for vocational-technical education and the concept of a community college system for Maine.

In 2003, Michael Michaud was sworn in as United States Congressman to represent the Second Congressional District in Maine, the largest congressional district east of the Mississippi River, stretching from Lewiston and Southwestern Maine to Calais and Downeast Maine, to Fort Kent and Aroostook County. Congressman Michaud serves on the Committee on Veterans' Affairs and chairs the committee's Health Subcommittee. He also serves on the Committee on Transportation and Infrastructure and the Committee on Small Business with a focus on economic development and job-creation financing for depressed regions of northern New England, fair pricing for prescription drugs, and support for the Maine Institute for Human Genetics and Health, a pro-economic development agenda that has made him a leader of the "Blue Dog Democrats."

And, as always, he returns to his roots – his home town, the home his grandmother lived in, his friends and fellow workers of the upper Penobscot River, and to the Great Maine Woods. Of his life and service to the nation, state and the people he loves, let us say, Très Bien!

Michael H. Michaud, for your dedicated service to the People of Maine from every walk of life, your love and advocacy for Maine's natural environment, your commitment to the Maine economy and our veterans, and your leadership in State Government and the Halls of Congress, the Husson College Board of Trustees hereby bestows upon you the Honorary Degree of Doctor of Public Service, with all the rights and privileges pertaining thereto.


On Thursday, September 27, 2007, Husson broke ground on a 55,000 square foot Meeting House.

“We need more academic space for surging enrollments, a place where students and the Bangor community can gather for college and cultural events and a place our alumni can call home. Just as in a traditional gathering place around an old New England village commons, our new Meeting House brings the community, school, culture and the arts together,” said Husson president Dr. William Beardsley.

The Meeting House will be comprised of the balconied 500 seat Gracie Theater, named for Grace “Gracie” McCollum,

granddaughter of Husson Trustee and friend Hilda Hutchins McCollum. An academic wing to house Husson’s School of Science and Humanities, the Joe & Suzanne Cyr Alumni Center with alumni lounge, archives, hall of honors and executive offices are all connected by the central two-story Ed & Mary Ellen Darling Atrium with its spiral staircase, wall galleries and glass atrium sky light. The academic wing will be open for classes in September, 2008. The Darling Atrium and Cyr Alumni Center will open in October 2008, and the Gracie Theater will open to a planned stage performance in early 2009. Acoustic and theatre design consultants are Walters Storyk Design Group of New York.

The academic wing will house Husson’s expanding undergraduate and graduate programs in English, Psychology, Criminal Justice, Pre-law/Paralegal and Science & Humanities. “Undergraduates in Business, Health, Education and Communications majors take courses in the liberal arts and minor in liberal arts as well. Our liberal and fine arts programs and faculty will now all be housed together. Add the Gracie Theater and collaboration among Husson, NESCom and the Seminary and undergraduate religion and performing arts majors cannot be far behind,” said Husson’s Chief Academic officer Rick Stephens.
