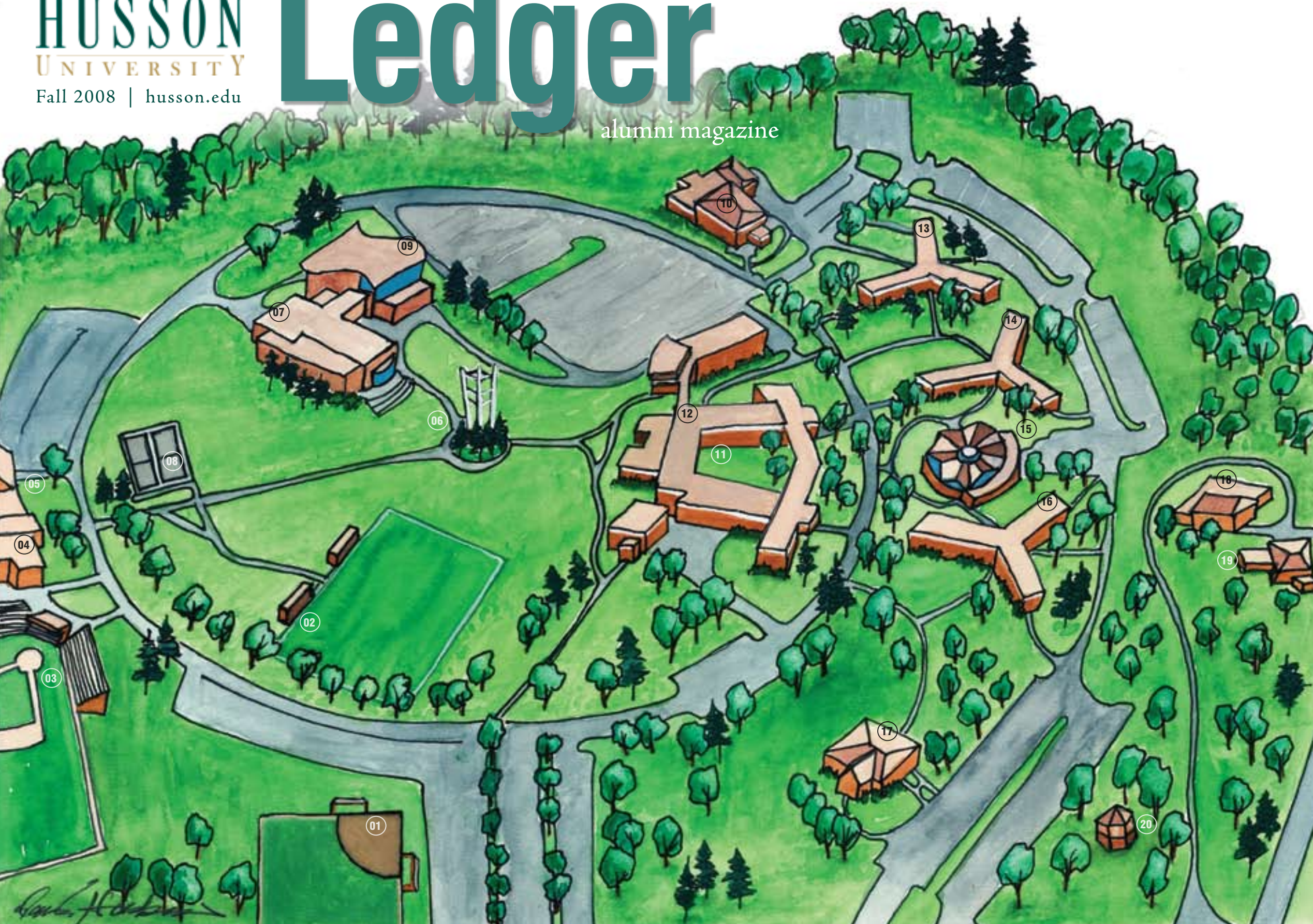

# A University in the making

The year 2008 will be exceptional for the entire Husson community – truly a year to remember.

Leading the way, Husson College officially became Husson University on Sunday, October 12, 2008. The Board of Trustees voted to approve the name change in recognition, not of what we aspire to be, but rather of what we've already become. Husson's mission and academic core have evolved with the times to serve the ever-changing needs of Maine's economy and professional workforce. As Husson makes its transformation to university status, it still remains a teaching institution that puts undergraduates center stage – and that's what sets us apart. As we embark on this new voyage, let's look at the coming of age of Husson University – our College Circle Campus – and consider where the pursuit of core values will next lead us.

## *Some Things Never Change; Yet Change Is Everywhere*

At its core, Husson has always been comprised of three fields of interest: business, health, and professional studies. These three fields continue

to serve as cornerstones in Husson's academic mission.

Founded as Shaw Business College and School of Penmanship in 1898, Husson has evolved into the undergraduate Husson College with a focus on business and accounting. The business school gained professional accreditation and prospered. Boasting 1000 students, it remains the heart of Husson University – as so many alumni and friends knew it in the past and as others still know it today. But it's also changing, with new concentrations in hospitality and sports management gathering momentum and serving as a platform for potential doctoral programs in leadership and law.

Also founded in Bangor in the 1890s as the Bangor General Hospital School of Nursing, the RN diploma program, along with its strong alumnae and traditions, became part of Husson in the 1980s. Since then, it has expanded to offer a bachelor of nursing, graduate nursing, and master's and doctoral programs in occupational and physical therapy, respectively. And, with final professional approval in process, a doctor of pharmacy program is in the making. Husson's collection of health-related undergraduate and graduate programs enroll 800 students. Turning out nurse practitioners, Husson is becoming a dominant force in the delivery of primary care health. Like physical therapy, pharmacy will provide the necessary training and licensure that lead to the professional doctoral degrees and certification the field requires.

The third and final cornerstone in the foundation of Husson is professional studies. Behavioral science courses have evolved into new academic degrees in psychology, counseling and criminal justice. The 80 students matriculating into the biology and chemistry programs this fall think of themselves as pre-

physical therapy and pre-pharmacy. Writing and paralegal programs lead to pre-law. The New England School of Communications is welcoming students with interests in applied technology, speech, and music. Husson has rebuilt its teacher education presence with a focus on elementary and physical education, school counseling and alternative certification. This fall, close to 1200 students are pursuing professional studies at Husson.

## *A University That Still Prizes Teaching and Undergraduate College Life*

Husson stands by its founding academic core and is steadfast in ensuring that Husson University will not lose sight of the school's rich history.

**A Focus on Teaching** Husson University is now hiring an ever higher percentage of faculty with doctoral degrees. Despite diversity in faculty interests, Husson's primary focus remains on excellence in teaching and on attracting faculty who practice what they teach.

**A Focus on Applied Degrees** Whether a student seeks a doctorate in physical therapy, a master's in teaching, a bachelor's in business, or a one-year certificate in boat building, Husson continues to concentrate on applied knowledge and skills that lead to licensure and/or careers. Husson does not offer, nor does it plan to offer, research-based PhDs or large scale pure liberal arts degrees.

## **An Undergraduate Collegiate Campus**

Husson University is dedicated to remaining undergraduate-centric. Husson and the New England School of Communications matriculated 1000 undergraduates during the 2008 calendar year. More than 90 percent are in their late teens. Half live on campus. Half play sports and get involved in college activities. And while it's true that many

of these students are entering five and six year master and doctoral programs right out of high school, they're still just 18-year-old undergraduates. College life for students at Husson – including social, service and academic clubs, music, sports, Greek life, ROTC and prayer groups – is vital and expanding.

**Our Diamonds in the Rough** Historically to the present day, close to half of Husson University's traditional undergraduate students are from the first generations in their families to go to college. Most of these students qualify for Pell grants, a national indicator of serious financial need. Sixty-eight students who entered this fall come from families with annual incomes of less than \$15,000. We have one of the most affordable tuitions of all the private colleges in New England for the exact reason our founder Frank Shaw stated in 1898: "No student should be denied such an opportunity because of financial straits or limited formal educational opportunity." These words are still the mantra. Even as Husson values students from every walk of life, it is the diamond in the rough we continue to prize.

**By Our Fruits We Will Be Known** Husson University takes its measure of success from its alumni – their career achievements and how they live their lives. As Husson becomes a university, its known alumni exceed 20,000 men and women. Their lives are a testament to what it means to earn a Husson degree.

**The Spice in the "Husson Stew"** Alumni and friends often ask about all the activities around the College Circle Campus, the co-location of the New England School of Communications (NESCom),

Bangor Theological Seminary, and, most recently, the offices of Bangor Symphony Orchestra.

NESCom is a wholly owned subsidiary of Husson University. NESCom, which focuses on hands-on learning and technology, simply beats to a unique "applied-technology" academic drummer. Husson offers other applied technology programs as well, such as the Eastport Boat School. With the goal of paying their way, these programs offer entrepreneurial approaches to education that allow Husson to serve both individuals and the state of Maine.

Bangor Theological Seminary is the only regionally accredited seminary in northern New England. A totally separate organization, their graduate students and scholarly faculty are valued additions to the campus.

Bangor Symphony is the oldest professional community orchestra in the nation. Its association with Husson allows us to provide the symphony's corporate offices. And through collaboration, the symphony helps us pursue ways to enhance music offerings on campus. These two institutions use little space on the College Circle Campus, but they add exceptional academic and cultural spice to the "Husson Stew."

### *College Circle Emerges as a University Campus*

**The College Circle Campus** In the late 1960s, President Chesley Husson dreamed about filling the empty spaces on the College Circle Campus. Now, through growth, diversification, and financial strength, those empty spaces have largely been filled, and an active, vibrant campus has emerged.

The original residence halls, dining commons, Peabody Hall, gymnasium, and bell tower that constituted the new campus in the late 1960s still remain. Yet as Husson moved toward becoming a university, the physical plant grew, and Husson now offers so much more.

The O'Donnell Commons added facilities for the schools of health and education. The Wildey Building houses the New England School of Communications. The new Meeting House added the Darling Atrium, Fuller Board Room, Cyr Alumni Center, a wing for the school of science and humanities, and an acoustically superior performing arts instructional center, the Gracie Theatre.

The Dyke Center serves Maine's family businesses and functions as the university's conference center. The gym and pool are now surrounded by the Swan Fitness Center, Kenduskeag Motion Analysis Research Lab, Winkin Sports Complex, Boucher Athletic Field, and O'Keefe Softball Field – to name a few.

To the Peabody Hall expansion and renovation, Husson added the Webber Campus Center, Sawyer Library, Furman Student Center, Willey's Café, and the Cressy Marketplace.

The Arboretum has matured, and the 150-year-old Federal-style president's home and Quirk House have opened the campus onto Broadway Avenue. The south entrance has transformed into Cross Lane, and construction is underway for a new north entrance through the 80 acre Husson Pines.

Add all this together, and it sure looks and feels like a university. In fact, it is! It's Husson University – our university – and it surely gives us pride.



In June we closed out our 2007/2008 fiscal year with net assets increasing by \$3.5 million to \$41 million. In September our total enrollments for Husson and the New England School of Communications exceeded 3,000 students for the first time. Bangor Theological Seminary, which shares our campus,

has welcomed its new president, Kent Ulery, and the Bangor Symphony Orchestra has moved its offices to the campus as well. Unobskey College in Calais and the Boat School in Eastport continue to grow. All this feels like a university.



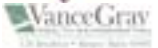

## Eagles continue to soar

The Eagles continued to soar in 2008 with success on the courts and playing fields as well as the classroom. Basketball, baseball, and softball programs all had a solid season and made strong post season appearances.

Softball had a record breaking season finishing with a program record 30 wins and the #1 seed in the NAC Championship hosted at the O'Keefe Softball Field. The Eagles came up short in their championship bid losing in the semi-final round. Coach Amanda Davies was named 2008 NAC Softball Coach of the Year, while leading her team to a record of 30-12 overall and 17-3 in NAC play.

Men's basketball had a solid season finishing at 18-11 and 10-3 in the NAC. They earned the #2 seed in the NAC Championship, losing in the semi-final round. The Eagles earned a post season bid to the ECAC New England Championships they were seeded #5 in the eight team championship. They went on the road in the first round to upset #4 seeded Fitchburg State, then lost the semi-final game at home in a heart breaker to U. New England 77-72.

**Jason Harvey '07** stepped in to fill the shoes of legendary coach Dr. John Winkin who suffered a stroke in December. Coach Harvey guided the baseball team to the championship game as the #4 seed in the NAC Championship. They fell short in their championship bid, losing two straight to Castleton State. They finished the season at 16-23 and 5-5 in the NAC. Coach Harvey

was named Head Coach in June.

Women's basketball finished the season at 16-11 and 11-3 in the NAC. They were the #3 seed in the NAC Tournament advancing to the semi-final round before losing to Maine Maritime 57-43.

Women's Swimming had a solid year competing in 8 meets, recording one victory against Regis College. Six Eagles competed in New England Championship, two individuals and one relay team.

Men's and Women's Lacrosse will play a full schedule in spring of 2009. The teams will play their home games on the Boucher Athletic Field. Mark Hundhammer has been named the women's lacrosse head coach and an announcement for the head men's lacrosse coach is expected soon.

In other news, Coach Gabby Price asked to relinquish his duties as athletic director and concentrate on his duties as head football coach. President Beardsley accepted Coach Price's request and named Dr. Rick Stephens as athletic director. Dr. Stephens, with 17 years of intercollegiate coaching experience will continue his duties as chief academic officer while assuming responsibilities for athletics. According to Stephens, "While academics is the proper focus of Husson, the building of character in everything we do is at the heart of our mission. Therefore, I see the playing fields or the courts as an extension of the classroom, and look forward to working with the coaches and student athletes."

## Honorary Doctorates



### Joseph F. Dooley

Vermont native and 1975 Husson graduate, Joseph F. Dooley began his career just weeks following graduation with the then little known Duracell Company in Scottsdale, Arizona. Twenty one years later (1996) Dooley was appointed President of Duracell Canada, then President of Gillette North America. In 2006 he became President of

Duracell Global and Chairman of Nanfu Battery Company, Nanping, China. Upon his retirement in 2007, Duracell had become the world's leading producer of high performance alkaline batteries. His work over those thirty two years placed him center stage with Duracell, The Gillette Company and Proctor & Gable. Today Dooley is a private investor and director of Carestream Health, Inc., a world leader in medical and dental imaging – a spin-off from Eastman Kodak. In November of 2007, Irish American Magazine recognized Dooley as one of the “top 100 Irish Americans in Corporate America.” He now spends increasing amounts of time with his wife Rebecca (a 1973 Husson graduate), and daughter Elizabeth. In May of 2008 Dooley received an Honorary Degree of Doctor of Business Administration from Husson.



### Hilda Hutchins McCollum

Hilda Hutchins McCollum has dedicated her life to service: church, charities, colleges and the fine arts. She has served as a Trustee of her alma mater, Colby-Sawyer College, as Vice Chair of the Board of the Bangor Theological Seminary and, for the past twelve

During her years living and raising a family in Washington, D.C., McCollum began as a volunteer with Goodwill Industries Volunteer Services ultimately becoming a member of the Board of Goodwill Industries of America. While in our nation's capital, she chaired the Board of Governance for the Columbia Lighthouse for the Blind, became treasurer of Washington's “The Lighthouse” charity, and chaired the National Cathedral's largest annual charity event, “All Hallows Guild Flower Mart.” In recognition of her outstanding service, President Reagan appointed her to his National Commission on the Disabled. Returning to Bangor in 1995, McCollum became active on the Boards of Good Samaritan Agency, the Bangor Symphony, Maine Tree Foundation, and chaired the Endowment campaign of the Advisory Board to the Maine Center for the Arts. Without her leadership, the Kenduskeag Research Institute in Husson's athletic complex would not exist. When Husson set out to build its new Meeting House complex, she provided the lead gift. In gratitude, Husson has named the new performing arts center “The Gracie Theater” for her granddaughter, Gracie McCollum. In May of 2008, Husson awarded her the Honorary Degree of Doctor of Public Service.
