

Speronis had an interesting take on why going from \$7.50 to \$12 by 2020 is too fast. "If you have \$60 an hour to spend on labor let's make it \$4 an hour, easy math, you can afford 15 servers an hour. If it goes to \$12 an hour you can afford five. That means service goes down, how do you avoid that? You have kiosk ordering, and then that's loss of jobs" (Chris Facchini, WLWZ). No matter if you are on the fence or have made a choice on the matter this is just food for thought.


