FAMOUS AUTHOR TO LECTURE AT HUSSON UNIVERSITY

On April 20th well renowned and New York Times bestselling author, Tess Gerritsen, will be speaking at Husson University. This author had the opportunity to sit down and interview Tess Gerritsen over the phone. The interview went as follows:

Tiffany Harvey (TH): What was college like for you?

Tess Gerritsen (TG): I went to Stanford University where I was a double major in Anthropology and Pre-Med. I was under a lot of pressure because I wanted to go to medical school. I wish I could go back because I was always under pressure. So I wish I could have experienced college without it.

TH: Do you have any valuable advice you would like to impart on Husson University students?

TG: Just be open to everything. Take classes in subjects you like. Just explore and expand your

TH: How did you end up in Maine? How have you found it so far?

TG: Well, my husband and I came here on vacation and it was just beautiful. We came at the right time.

TH: Unlike what we're having now, right?

TG: Exactly. I just loved it. To me it felt like home. Maine is a great place for the arts and to be creative. It also allows me to focus.

TH: Could you tell me a little about your new book? It's called *Ice Cold*, am I correct?

TG: Yes you are. It's another Jane Rizzoli/Maura Isles book. It's about Maura Isles, who goes to Wyoming for a vacation. While in the town where she is staying the people are vanishing. As well, a snowstorm hits and strands her in this town. Every time she tries to escape something bad happens to prevent her from leaving. The snow really isolates Maura and it lends an opportunity for Maura to think about things. Is she going to get together with the priest? How is she going to get out of this town?

TH: Wow! That sounds like a great setting for a book. I'm really looking forward to reading it. Another question I wanted to ask was, is *Ice Cold* your eighth book?

INTERVIEW WITH TESS GERRITSEN CONTINUED

- TH: Where do you find inspiration for each consecutive book that you've written? With a lot of series I've read, by book eight or nine the storyline has lost staying power or the story line is so convoluted I can't identify with the main character. What do you think causes this?
- TG: Honestly when I'm writing I think, "Who are these people? What's going on?" I think a lot of authors lose sight of that. Also they get into the danger of running out of story lines.
- TH: Exactly. That's how I have felt. I heard that TNT is picking up a series based upon your books. Also, I read and saw the pictures of you visiting the TV set on your blog. Are you happy with the way things are going?
- TG: Yes, TNT is actually picking up a first season- ten episodes. It is supposed to air in July. I felt the writers are terrific and are doing an excellent job. The stars are just great. I'm happy.
- TH: I saw that Angie Harmon, who I've seen on Law and Order and Sasha Alexander, who I've seen on NCIS, is going to play Jane Rizzoli and Maura Isles. Do you think they are a good fit?
- TG: Absolutely. Angie is just a great person, has a great personality. She has that tough girl attitude that makes her great to play Jane Rizzoli.
- TH: Are you happy with them casting Sasha Alexander as Maura Isles?
- TG: Oh yes, she's great. Sasha is very elegant and cool, which is exactly how I pictured Maura.
- TH: I know I will be watching the series when it comes out.
- TG: Thank you.
- TH: As a writer, do you have any tips for current and/ or future writers?
- TG: Basically just stick with a story and see it to the end. Sometimes writers get halfway through and don't know how to finish a story so it becomes never ending. Writers can get lazy like that. So just stick with a story and the characters through to the end.
- TH: When you mean story do you mean by one story line? Often books I've read with start off with one then integrate so many that I get confused. Is that what you mean?
- TG: No, I mean just stick with what you start with.
- TH: Well that's great advice- simple and easy. So I heard a rumor that you played the violin with Stephen King in a band- The Rock Bottom Remainders. Is that correct?
- TG: Yes, I played one performance for a charity event in Bangor.
- TH: How did that come about?
- TG: They just called me up and basically asked if I wanted to play to benefit this particular charity and I said yes.
- TH: Did you enjoy that experience?
- TG: It was interesting for me. I am not much of a rock 'n roll person so playing my fiddle with that type of music was interesting. I enjoyed it though.
- TH: Well thank you for your time. We are excited to have you come to Husson to speak and are looking forward to it.
- TG: I am too.
- TH: Thank you. Have a good day.

NEW COURSE—COMPUTER FORENSICS

In the Spring 2010 semester a new Criminal Justice course was created. This course, Forensic Computers, was designed recognizing that many traditional crimes now involve the use of computers and wrongdoing previously never imagined has surfaced because of the capabilities of information systems. The course will focus on the investigative use of computer technologies and electronic records. Students were exposed to "digital evidence" and the valuable information it can provide to investigations. The course was designed with a two tier approach; at the start of the semester the course examined criminals who use the computers and the Internet to commit various crimes ranging from trying to lure children into chat rooms or face-to-face meetings to every sort of financial fraud and applicable laws will be discussed. Then students were shown how to extract readily decipherable information from someone's computer by looking at their files or their browser history of web sites visited. Even if the information is password protected or has been deleted it might still be recoverable. The course is intended to address a growing need in law enforcement at all levels.

The enrollment was limited to 24 students who must be at least in their junior year.
