INTERNSHIP INVESTMENT BANK



There is a new "bank" in town. The College of Business at Husson University announced the establishment of a unique "Internship Investment Bank".

"The Internship Investment Bank is a partnership between the College of Business and the Corporate and Non-Profit Community," stated Dr. Ron Nykiel, Dean of the College. "The purpose of the bank is to encourage work experience opportunities for students while providing educational benefits to employers."

For each new paid "intern" (student) placed in a corporation or non-profit organization, the employer receives a \$500

credit deposited into an account in the entity's name. These deposit credits can then be used toward the cost of an MBA degree at the College for an employee of the entity. Nykiel states, "This is a win-win scenario for

both the student, company or non-profit organization, and the College."

"The Internship Investment Bank will be run by the School of Accounting with the College of Business, providing yet another work experience for our accounting students," stated Dewey Martin, Director of the School of Accounting.

Husson will offer Masters of Business Administration (MBA) classes at The Jackson Laboratory beginning Jan. 17, 2012. The arrangement calls for the College of Business to provide Laboratory employees and Bar Harbor-area residents the opportunity to earn an MBA degree on site. Dr. Tom Hutchison, Executive Director for Academic Affairs in the COB explained, "Students will be able to complete the MBA degree in two to three years through a combination of online classes and classes taught on site. We have designed this program so students will not need to travel to our Bangor campus for any coursework."
