CRIMINAL JUSTICE PROGRAM

COURSES BEING DEVELOPED AND RESTRUCTURED:

CJ 309-CONSTITUTIONAL LAW-is a new course focusing on the major provisions of the U.S. Constitution. Students will explore the meaning of federalism, the doctrine of separation of power, and the role of courts in serving as a guardian of Constitutional rights and liberties of individual citizens. The course will also examine historical circumstances and events leading to the birth of the Constitution and factors that influenced the drafters.

CJ 221—CRIMINALISTICS has been redesigned to include some of the new technology used in criminal investigations such as Faces and Map Scenes. The evidence found at



crime scenes is referred to as the "silent witness" and this course will focus on methods to extract all the information this witness has. At the conclusion of the course, students will work a crime scene, develop a criminal profile, apply for necessary warrants and brief their case theory to an attorney.

CJ 499–TERRORISM–was presented for the first time in SP 09. Students analyzed aspects of historical and current terrorism. Some of the topics covered included the ancient roots of terrorism, the motivation of terrorists, the current vulnerability of modern democracies, global jihad and 9/11 events.

COURSES RECENTLY ADDED:

CJ 408 - SERIAL HOMICIDE -examines detailed case presentations which allow selected offenders to be studied in regard to modus operandi, offense behavior and victimology.

CJ 409- CRIMINAL

PROFILING—examines behavior evidence analysis and practices including wound pattern reviews, psychological autopsies, and crime scene reconstruction in regard to unknown suspects.

PARALEGAL STUDIES PROGRAM

NALS COURSE OFFERED FOR THE THIRD TIME AT HUSSON

NALS of Northeast Maine (Association for Legal Professionals) is providing instruction for the Basic Legal Studies course. This course addresses: Legal Research; Accounting; Torts; Criminal Law; Family Law; Ethics; Bankruptcy; Real Estate Law; Estates and Guardianships; and Business Organizations. The students also receive the Basic Manual for Lawyer's Assistants which

is an valuable resource. At the end of the course, students are able to take a 4 hour, 3 part exam on written communications; office procedures and ethics to obtain the ALS basic certification for legal professionals.

Students interested in pursuing a Juris Doctor (J.D.) degree now have the opportunity to enroll in the Pre-Law program. This program combines a major in English with a Paralegal Studies certificate. Students will hone their writing, communication and research skills in this program in preparation for law school. Additionally, the Paralegal classes will expose the students to many of the traditional law school subjects. Students will also have the opportunity to participate in an internship in a legally oriented setting and receive advising for their plans for law school admission.



Both CJ and PL students are finding success and future careers at their internship location sites. The number of students seeking out the experience of internships has grown substantially since 2003.

LAW DAY 2009

May 1st is the national day set aside to celebrate the rule of law. Law Day underscores how law and the legal process have contributed to the freedoms that all American share. In honor of Abraham Lincoln's 200th birthday, the theme established for Law Dav by the ABA is Lincoln's Legacy of Liberty. Lincoln, who devoted much of his adult life to the practice of law, was the quintessential American lawyerpresident.

Students will be encouraged to explore Lincoln's legacy in many of their paralegal, criminal justice and history classes. The movie <u>Young Mr. Lincoln</u> (1939) will be shown to illustrate his prowess in the courtroom during the defense of two men unjustly charged with murder.

MEET THE FACULTY CONTINUED

John Michaud received his B.A. in Philosophy from St. Francis College (now Univ. of New England). He also obtained two Master's degrees-one in Human Relations from Webster University and one in Strategic Studies from the Naval War College. He served in federal law enforcement with NCIS for 25 years, working specifically in the Terrorism division. After leaving the military he managed corporate security at the Olympic Games in Atlanta, GA for the International Olympic Committee. He later worked as a special consultant to the Boston Police Department. Prior to coming to Husson, John was V.P. in the Personnel division and later V.P. in Telesales at MBNA.

Paul Morrow received his B.S. in Business Administration with an emphasis in Economics. Finance and Accounting from the University of Maine. He then received his J.D. from Franklin Pierce Law Center. Paul spent 6 years working in investments and finance followed by 12 years of working in litigation in the Bangor area at the District, Superior and Federal courts. Paul is also specially credited from writing the winning brief to the Maine Law Court that helped define the current Protection from Abuse law. Paul has also recently had a national publication focusing on the Enforceability of Contracts in Cyberlaw.
